# Lift Unit Installation

- 1. Truck must be empty, clean and parked on a level surface before installation is started.
- 2. Remove all bumpers and running boards that will interfere with the location of the lift units. Relocate lower mounted tail lights as needed.
- 3. Measure and mark the centerline of the truck hopper. The centerline of the unit or units should be a minimum of 17" from the hopper centerline.
- 4. Hand valves should be mounted on the side of the hopper at the most convenient height for the operator and clear of the packer controls.
- 5. The top of the unit mounting plate should be tack welded in place at the height recommended on the envelope dimension sheet of the unit. CAUTION: SEE NOTE BELOW PICTURE
- 6. All dimensions should be approved by the customer before final welding.
- 7. If the mounting plate extends more than 2" above the hopper, a brace should be added.



Mounting heights and locations are recommendations only. It is the responsibility of the installer to insure that the customer is satisfied with the height. Barker Products recommends that after the units are tacked in place, try the units with the can or cans the customer uses. The customer should approve your mount before final welding.



On any work not performed by BARKER PRODUCTS or it's representitive, the customer will be responsible for freight charges on all parts shipped under warranty. Parts will be invoiced at time of shipment. Defective parts must be returned to BARKER PRODUCTS within 30 days. If the part is determined to be defective the customer will be credited for the original invoice.

Customer warranty labor charges must be approved by BARKER PRODUCTS in advance. If not contacted for approval, BARKER PRODUCTS will not be liable for the warranty labor charge.







#### BPHB27-55 SERIES LIFT UNIT SPECIFICATIONS

THE FOLLOWING SPECIFICATIONS ARE INTENDED TO DESCRIBE EQUIPMENT FOR A SEMIAUTOMATIC REFUSE COLLECTION SYSTEM WHICH WILL UTILIZE ANSI Z245 TYPE B RESIDENTIAL CARTS AND HYDRAULIC LIFTING MECHANISMS (DUMPERS) INSTALLED ON REAR LOADING PACKER BODIES FOR DUMPING THESE CARTS.

- 1. THE DUMPER SHALL CONSIST OF A STATIC SUB-FRAME BOLTED TO STEEL PLATE (BOLT ON KIT) WELDED TO THE HOPPER AND A DYNAMIC LIFTING PLATE (SHELL).
- 2. THE MOTION OF THE LIFT PLATE MUST ALLOW FOR FAST AND EASY ATTACHMENT OF THE CART WHEN USED ON ROUGH AND UNLEVEL STREET CONDITIONS. IN THE STORED POSITION THE LIFT PLATE WILL BE RECESSED BACK UNDER THE TRUCK AT A 55 DEGREE ANGLE AND MOUNTED TO HAVE A MINIMUM GROUND CLEARANCE OF 20".
- 3. THE DUMPER SHALL HAVE A COMPLETE CYCLE TIME (GROUND TO GROUND) OF 6 TO 10 SECONDS.
- 4. ALL PARTS MUST BE REMOVABLE FROM THE STATIC SUBFAME WITH HAND TOOLS WHILE THE SUBFRAME REMAINS ATTACHED TO THE TRUCK.
- 5. THE DUMP ANGLE OF THE LIFTING PLATE WILL BE 50 DEGREES.
- 6. THE LIFTING PLATE (DUMPER SHELL) WILL BE CONSTRUCTED OF 5/16" STEEL PLATE WITH STEEL RIBS WELDED VERTICALLY FOR ADDED STRENGTH. THE LIFTING PLATE MUST BE EASILY REPLACEABLE IF DAMAGED (ATTACHED TO THE STATIC FRAME USING GRADE 5 BOLTS).
- 7. THE UNIT WILL BE LOW MAINTENANCE WITH NO GREASE POINTS ONLY ON ACTUATOR SHAFT SEAL.
- 8. THE LOWER LOCKING LATCH ON THE LIFTING FRAME IS MECHANICALLY OPERATED SO THAT IT SLIDES DOWN TO SECURELY LATCH ON TO THE LOWER BAR OF THE CART AS IT IS BEING LIFTED. THE LATCH MUST THEN BE CAPABLE OF HOLDING THE CART FIRMLY IN PLACE IN THE INVERTED POSITION, EVEN IF THE CART IS SHAKEN TO REMOVE ALL REFUSE FROM WITHIN. BEING MECHANICALLY OPERATED, THE LATCH MUST THEN SLIDE UP TO RELEASE THE CART BEFORE IT CONTACTS THE ROAD SURFACE AS IT IS LOWERED. THE LATCH MECHANISM MUST BE BOLTED TO THE LIFTING PLATE FOR EASE OF REPLACEMENT IF DAMAGED. TENSION SPRINGS ONLY ON THE LOWER LATCH, NO TORSION SPRINGS.
- 9. THE LIFTING PLATE IS POWERED BY A HELICAL ROTARY ACTUATOR WITH SPLINED SHAFTS RATED FOR 220 DEGREES ROTATION. AT 3000 PSI OPERATING PRESSURE THE ACTUATOR WILL HAVE A TORQUE RATING OF 25000 INCH POUNDS.
- 10. THE UNIT MUST BE MOUNTED SO THAT THE LIFTING PLATE CAN NOT BE CONTACTED BY THE PACKER BLADE.
